Acknowledgement and Assumption of Risk

Warning: this may effect your legal rights and obligations. I want to play paintball with Delta Force Paintball and sign this document in consideration of being given that opportunity to engage in this activity.

I ACKNOWLEDGE AND UNDERSTAND THAT

- I agree to participate in the paintball event entirely at my own risk. I recognize that there are hazards throughout the entire centre including the car park, base camp, access tracks and game zone areas. These include, but are not limited too; fallen trees, sharp objects, holes, burrows, trip hazards, slip hazards, roots, game structures, buildings, barricades, raised platforms, vehicles, stairs, walkways, mud, loose ground, standing water, animal/insect activity, stray shots and that pellets can bruise or break the skin.
- The game is physically and mentally intense and may require exertion to play;
- The game can be dangerous if not played in accordance with stated playing rules which I have read and understand;
- The possibility of injury to myself and other exists;
- Any breakage or loss of equipment loaned to myself during the day will be charged to me at cost price;
- Delta Force Paintball accepts no responsibility for personal property lost or damaged during the day and that customers vehicles are parked entirely at the owner's risk;
- I may be injured and/or suffer damage to my property as a result of my negligence or breach of contract;
- I assume the risk of responsibility for any injury, death or property damage resulting from my participation;
- I confirm I have read the recommended footwear requirements. I recognize that if I am not wearing the recommended footwear I am participating at a significant higher risk of injury, especially if ground conditions are poor.
- I will familiarize myself with the playing condition warning board displayed beside the stage and I understand that there will be a heightened risk associated with participating under Yellow, Red or Black flag conditions, and I will act accordingly to the instructions given on that warning board.
- The conditions in which the activity is conducted may vary without warning.
- I will give special attention to all instructions oral or written and will query any matters I do not understand.
- There may be no or inadequate facilities for treatment or transport of me if I am injured.
- I am not under the influence of drugs/medication/mind altering substances, nor do I have any allergies or pre-existing medical condition
 - Effect my understanding of safety instructions;
 - May be exacerbated by the activity; and/or
 - Prejudice the performance/safety to myself or others.
- Other persons participating in the activity may cause me injury or damage to my property for which they may be liable.

- I may cause loss or damage to property used/hired for which I may be liable.
